After discussion Trustee Johsz made a motion to accept the rate increase. Seconded by Trustee Breitling. Motion passed unanimously.

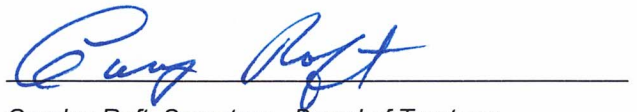
13. ADJOURNMENT - The Meeting was adjourned at 12:11p.m.
